- 1. The UG and PG Final Semester Examination of UTDs/Colleges/Institutes be held w.e.f. 21.06.2022.
- 2. The Practical examination (Viva-voce/Training/Dissertation etc.) for the same shall be conducted by Offline Mode after the completion of theory examinations by internal regular /approved faculty members who can act as the external examiners. In case of affiliated Colleges/Departments where regular/approved faculty is not available, the external examiner(s) from the duly approved panel of examiners shall be appointed from nearby University/College (not more than 100 k.m.) by the Chairpersons/ HOD's / In-charges/Principals/Directors at their own level.
- Even Semester Examinations be conducted through offline mode only. Further, no application
 with respect to conduct of examination through online mode from UTDs/Colleges/Institutes etc.
 be entertained.
- 4. The students be allowed to attempt any 05 Questions out of 09 Questions.
- 5. The time duration of the exam will remain 03 hours/2 hours as per scheme of examination.
- 6. Revised Academic Calendar be issued by the Academic Branch, CBLU, Bhiwani.
- Extra classes be arranged by the Chairpersons/ HOD's / In-charges/Principals/Directors of UTDs/Colleges/Institutes concerned to meet the deficiency in teaching, if any.
- 8. The remaining Even Semester examination and Supplementary Examination of UG and PG be commenced w.e.f. 11.07.2022.
- 9. The examination of B.Ed./B.Ed.(Spl.), M.Ed./M.Ed. (Spl.), MA (SWDS) and PGDRP be held through Offline mode only as per scheme of examination.
